

Provet Cloud 1.111 Release Notes

Developments

- Added a feature that allows stock items to be moved between departments when moving products. A new user permission has been added for this. Permission "Can move stock between departments" has to be enabled for the user before stock moves between departments can be done.
- Added VILA reporting required field for medicine items in the API.
- Added a checkbox for marking medicine items to require reporting to authorities under Swedish VILA legislation.
- Created a new permission to regulate the access of users to tasks across departments.
- Added department group filter to supersearch.
- Added a filter to the importer's preview step that allows showing columns by property group.
- Added "No show" filter to Appointments table on Patient details page.

Fixes and improvements

- Changed the selection of field "Print dispensed medicine label" on the Bundle items dialog to only include printers from current department.
- Fixed invoice row bug that occurred when using the "Add fee as a separate invoice row"
 Handling fee method. Unchecking invoice row "Use handling fee" while adjusting medicine quantities now removes Handling fee invoice row.
- Added QR code placeholders for medicine items on countersale and invoice.
- Enabled department filter/department group filter to Discharge note templates in super search.
- Fix problem, that "Cancel check-in" modal wasn't closed after success. Also "Cancel check-in" wasn't hidden, if mark patient as ready for discharge.
- When cancelling health plan subscription, checkbox "create cancellation invoice" is not checked for subscriptions with "not specified" payment method.
- Fixed the issue where department-related reminder template placeholders were not matching the ones used in text templates.
- Fixed the issue where a manual save of discharge instructions in finished consultations would not save data added using the "Bring data" tool.
- Fixed an issue in the estimates page, where price field values could in some cases be incorrect.

- Added off-label warning to UK written prescription PDF.
- Fixed miss-aligned Medicine Instruction Templates section in add medicine to counter sale form.
- Fixed microchip high contrast color.
- Fixed the issue where the navbar on the left-hand side would be shifted upwards and only partially visible on clouds with only one department, or clouds with multiple departments where a user only has access to one department.
- Fixed the issue where it was not possible to use medicine instruction templates for medicine items added to counter sales.
- Fixed the issue where it was not possible to create a client/patient excel export when any of the database entries contained string values longer than 32767 characters.
- Fixed the issue where a non-active resource would be selected as the default resource for an appointment when booking with a reason type that the resource is linked to.
- "Start draft consultation" option is hidden from appointments action in appointments' table. This fix is visible when Draft Consultation feature flag is enabled.
- Extended REST API /stock/item/ endpoint with wholesale_price_unit and stock_value fields.
- Fixed a bug where the same batch appeared multiple times when adding an item and the quantity used was more than the remaining quantity of the batch.
- Fixed the issue where the 'Planned items' section on the consultation page would not load if no patient was present or selected (notable in 'Farm visit' type consultations).
- Fixed the issue where laboratory result graphs were being displayed with a Y scale not relative to the values that were being presented.
- Disabling a laboratory integration will no longer archive laboratory items if the "Enable automatic synchronization of laboratory items" setting for the laboratory is disabled.
- Fixed bundle total calculation on consultation addition of bundles.
- When importing from lists, added more detailed progress information while waiting to load a wholesaler item list.
- Fixed an issue where linked appointments would sometimes disappear from appointments calendar when saving them.
- Fixed the issue where not all appointment blocks for right-to-left languages had their text aligned to the right.
- Fixed an issue related to tasks link not navigating properly when clicked a second time.
- Added PDF label printing feature for consultation bundle items.
- Removed the link from the footer in login page as it requires the user to be authenticated in the system.
- Changed how laboratory referral deletion works in the database. Laboratory referrals are now soft deleted in the database instead of being completely removed when a user deletes a laboratory referral. This change does not affect the user interface of Provet Cloud at this time.
- Fixed reminder expiry date display.

- Extended REST API /stock/item/ endpoint with item_type_code and item_name fields. Both fields are filterable.
- Added new endpoint /item_diagnosis_group/ to API.
- In UK written prescription PDF, increased "Valid until" text font-size for readability.
- Removed "Alert level" default value in file importer. Avoids unwanted 0 alert levels.
- Added new organization setting "Active department checking when adding item on invoice or consultation". If enabled, the department of the invoice/consultation must be the same as the user's active department, otherwise adding items is prevented.
- Fixed an issue around unit-based injection fees for estimates when a separate fee row and quantity range is in use.
- Fixed an issue where price change rows were not visible in estimate PDFs.
- Quantity and price fields are no longer editable for handling fee and injection fee items
 relating to medicines on the estimate page. Since they are linked to a medicine item,
 they should not be editable on their own but only according to the medicine item.
- Set initial date to always show the "Today" time span in the Treatment Plan dashboard filters.
- Added functionality to link a Custom field and a Custom field option to a tag. Initially available to beta-testing cloud environments. Added to a broader audience in later phases.
- Fixed a bug that caused some orphan laboratory results not to appear in Provet Cloud.
- Improved the warning banner message for the potential duplicated client workflow.
- Improved UI for the potential duplicate client dialog.
- Fixed the overflowing filters toolbar in the Clients & Patients > Tasks tab > Tasks table when viewed on small screen or viewport.
- Fixed the overflowing filters toolbar in the 'Patient page > Vitals tab > Vitals filters' section when viewed on small screen or viewport.
- Fixed the overflowing filters toolbar in the 'Patients page > Labs tab > Laboratory tests' section when viewed on small screen or viewport.
- Changed appointment status text in the Dashboard's Scheduled appointment table from "No Show" to "No show".
- Fixed the issue where a copy of a fixed-price bundle did not keep the fixed-price property as it should.
- Fixed the sorting of stock locations in the stock location dropdown fields.
- Fixed the issue where the 'Add stock entry' button was available when editing consultation items for users without the 'CanAccessStock' permission.
- Fixed a bug where the list of available laboratories sometimes didn't update correctly when enabling the use of external laboratory integrations.
- Fixed filter dropdown menu opening in the wrong place when using RTL language.
- Improved navigation to the tasks page when using the "See all tasks" link in the header.
- Fixed issue where tasks cannot be created without client and patient.

- Changed the status label 'No Invoice' to 'No invoice' in the Recent consultations table.
- Patient placeholder options removed from financial summary.
- Added info-banner illustrating that a Bundle template has at least one item that has a minimum price set.
- Fixed an issue where diagnostic imaging linked to an appointment wasn't copied to consultation when admitting draft. Visible only if the Draft Consultation feature flag is enabled.
- Renamed the "Delete" button in appointment overview opened from consultation to "Cancel appointment" and made it a neutral color.
- Fixed issue where "Lastname, Firstname" notation was breaking table filters. User saved with filters was shown as two separate users: "Lastname", "Firstname".
- Adjusted the model order seen in the file importer's first step.
- Fixed a bug around how we display the item price when the quantity of the item is less than 1 or negative.
- Resolved an issue where item discounts from discount schemes were not being applied to Handling and Injection fees when added as separate rows in a consultation.
- Updated error messages for the 'Import from lists' feature to be more informative.
- Added organization setting to determine which payment methods are available for health plans.
- Added a new print setting to display a link with manufacturer data per given medicine on the invoice printout. Manufacturer data links can be saved on the medicine item configuration.
- Added new placeholder [[medicine_url_qr_code]] to 'Medicine' and 'Treatment plan medicine' label printing template.
- Added Discharge Time to the General Info of a consultation and the edit view of a consultation. Initially available to beta-testing cloud environments. Added to a broader audience in later phases.
- Fixed an issue where an appointment would not refresh on the calendar when changing its user to a user that was not selected in the filter sidebar.
- Fixed an issue where user account imports that included account expiration time yielded wrong results.
- Fixed misaligned filters on the Dashboard > Scheduled appointments table when viewed on a small screen or viewport.
- Fixed the filters overflow and overlapping elements under "Patient details > Patient referrals" table when using a small screen or viewport.
- Fixed an issue where selecting "Cancel and transfer to prepayments" for an automatically transferred cross-department payment would create a prepayment with an incorrect payment method.
- Added last recorded weight to the selected patient's field on Estimate page.
- Fixed a bug where controlled item balance was not properly refreshed after changing the tracking number on an existing invoice row.

- Fixed file importer mapping step messages.
- Improved the UI and logic of the Task table filters.
- Fixed an issue in our IF insurance claim mapping tool that was listing external labs for more departments than the active one.
- Fixed an issue with the original price and the price change displayed on the invoice printout for discounted items, when usage size is set to units.
- Fixed display of error messages in the importer's preview step.
- Fixed a bug where the status of an external laboratory integration showed as 'active' even though the integration had been deactivated.
- Fixed a bug where, as a result of activating the same external laboratory integration for different departments using the same item list, only one department could create referrals for the laboratory.
- Added automatic refresh for imaging referrals table in consultation if status changes in the diagnostic imaging referral linked to the consultation.
- Fixed an issue where the importer's additional settings in the mapping step did not save when using the return key to save.
- Fixed the issue with multiple applicable overrides for a 'Conditional pricing' rule. A rule is saved for every condition (currently item type, usage type and species).
- Update the action field with negative markups.
- Fixed a bug where the current amounts for available tracking numbers of a controlled substance always showed the remaining quantity in units, even if the user changed to use packages when adding a controlled medicine with tracking numbers to a consultation.
- Added new print settings for invoices and estimates that allow combining separate injection and handling fee rows into the medicine row that they each relate to.
- Improved client duplication detection algorithm.
- Fixed a bug where it was possible to update an external laboratory referral after the referral has already been sent to the external laboratory.
- Fixed a bug where external laboratory referral forms had the label "File" in Provet Cloud instead of "Order form".
- Fixed a bug where downloadable external laboratory attachments were incorrectly labeled as 'Redirect' instead of 'Download'.
- Added the possibility to filter with consultation start date and consultation end date in clients & patients search.
- Updated the permissions required to perform the Mass Discount action in invoices which is now tied to the "Can change prices on invoices" permission.
- Fixed issue with creating appointments from Patient referrals.
- Added functionality to apply conditional pricing on consultation and invoice. Initially available to beta-testing cloud environments. Added to a broader audience in later phases.

- Fixed a bug that allowed items from a different wholesaler to be added to an order from the main stock page.
- When using health plans, compensation item is now updated if the original item added from the health plan is edited.
- Fixed an issue where enabling the setting "Require veterinarians for medicine rows during counter sales" was affecting credit notes made from consultation invoices.
- Added a more restricted way of managing copied shared item bundles from central department in local departments. Initially available to beta-testing cloud environments. Added to a broader audience in later phases.
- Added possibility to copy item bundles from central department onto other departments.
- Improved item bundle search layout in item bundle settings page. Initially available to beta-testing cloud environments. Added to a broader audience in later phases.
- Possibility to configure overrides for conditional pricing schemes on the item level. This
 allows users to set up exception cases for certain items that should have a different
 markup than the scheme. It's also possible to mark that the item will not be affected by a
 conditional price. Initially available to beta-testing cloud environments. Added to a
 broader audience in later phases.
- Improved how package descriptions, unit descriptions, and units per package values are handled for medicines used from the Finnish Pharmaca Fennica medicine list.
- Added new organisation setting to define central department for bundles, healthplans, and item lists. Initially available to beta-testing cloud environments. Added to a broader audience in later phases.
- Fixed a bug where 0 quantity batches sometimes showed up as active batches for products.
- Fixed package and unit handling on health plan items when marking items used.
- Fixed the issue where setting a stock level was mistakenly required when adjusting the "Batch number required" option of items when importing.
- Fixed the content overflow produced when using a small window size in the "Counter sale" items table.
- Fixed an issue where the client edit modal wasn't opened from consultation > next steps > appointment > edit appointment > edit client.
